- **Book sufficient space** to safely include tent pegs, guy ropes, the entire outlines of vans trailers etc., all your goods; NOTHING OF YOURS can protrude outside your outlined space.

**Gates open** for exhibitors and vendors at 6am. **You must have set up** completely by 8.30am.

- Your **vehicle** must be **parked outside** the perimeter of the show grounds by 9am.
- You will be given a parking voucher
- **Exhibitors** must supply ALL their own equipment, e.g. tents, tables, chairs, etc.
- **Vehicles** found on the grounds after 9am may be clamped, unless they form part of your display. Release fee is \$100.00.
- Bring **sun screen**
- Bring **own sun/rain shelter**, required minimum height for shelters is 2m; the surface area of the showground is brown gravel or clay with short mown paddock grass, you may like to bring a ground cover
- You may begin **packing up no earlier** than 5pm.
- **You must remove ALL your own refuse** from the show grounds by the end of *the day*. **Show bins are for patrons only**
- **Legal Compliance:** You are required to comply with all statutory acts and regulations of Western Australia, including but not limited to Occupational Health, Safety and Worksafe requirements. Equipment log books (if applicable) must be current and available for inspection
- **Toy vendors**, due to insurance worries, please no water, laser guns, projectiles or toys which risk choking young children,. All toys to be compliant to Royal Australian Show conditions
